While on the appellate bench, Judge Rader has also served actively as an educator. He taught patent law and advanced intellectual property courses at the University of Virginia School of Law, Georgetown University Law Center, and the George Washington University Law School. Judge Rader is co-author of a casebook on patent law used at over 65 law schools. Judge Rader has received many awards including the J. Wm. Fulbright Award for Distinguished Public Service, 2000, the Jefferson Medal, 2003, a Distinguished Teaching Award, 2003, and a Distinguished Service Award, 2003. As an appellate judge, Judge Rader has also led or participated in over 60 delegations to foreign nations, usually to teach rule of law or intellectual property concepts in developing nations.

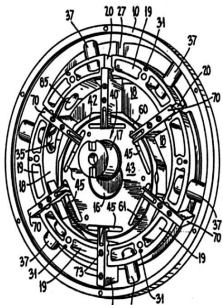
