## **About the Speaker: (cont.)**

He also prosecuted the high-profile network intrusion, denial of services, and web site destruction cases of PhoneMasters and globalHell, profiled nationally in the Wall Street Journal, ABC's 20/20, USA Today, The New York Times, U.S. News & World Report, A&E's Investigative Reports with Bill Curtis, and CNN.

Other: Internationally recognized expert in the area of e-commerce law and security; has appeared on such programs as Nightline with Ted Koppell. Has spoken extensively to corporate America from Fortune 500s to dot.coms regarding Internet, general ebusiness, privacy and corporate security issues. Recognized by The Texas Lawyer as an attorney that "cutting-edge technology companies turn to." Voted as one of "The Best Lawyers Under 40

in Dallas" in the May 2002 issue of D Magazine. Named to The National Law Journal's "40 Under 40" list.


